3. Please share any experience that illustrates your understanding of and interest in the needs of the LGBTQ+ community in your District/Role sought.

I am a two term council member, and my allyship has been demonstrated across my support and presence at everything from the Don Maison sign topper (I was on the three-signature memo requesting this memorial) to Pride parades and press conferences and the opening of Oak Lawn Place.

Do you make such an affirmation? What is your previous voting history (please explain any changes in party affiliation)?

Yes.

5. Please list some of your qualifications and experiences pertinent to the office you are seeking:

I have served two years as a Dallas City Councilmember representing District 13. Appointments by my predecessors include the Community Development Commission, the 2017 Bond Critical Facilities subcommittee, the Vickery Meadow TIF Board, and separately, the DISD 2020 Bond Safety & Security subcommittee. In addition to volunteer community roles around domestic violence, child abuse and maternal health, neighborhood park liasion and programs for an early childhood PTA, and civic organizations like Junior League of Dallas, Dallas Breakfast Group, Alzheimer's Association, Friends of the Dallas Public Library, and more. At the national level, I serve on the National League of Cities Finance Administration and Intergovernmental Relations Committee.

6. Once you are elected, what are some of your priorities and plans specific to your office's responsibilities?

Public safety and infrastructure (streets, alleys, sidewalks, stormwater drainage) are always paramount with Dallas residents. The City has been slow to act on temporary housing options for unsheltered residents—treating the streets and public spaces as waiting rooms as they (maybe) wait for housing. Activating spaces owned by the City or in partnership with nonprofits with existing relationships must move from talk to action before the end of 2025 (and hopefully by Q3!). Given the cascade of fear and uncertainty by the national administration, making sure Dallas' Office of Community Care is as agile and responsive as possible is key, as well as keeping communication channels open with communities most directly affected by rights cancellation attempts.

Housing

This section addresses housing and homelessness within the LGBTQ+ community.

7. On a scale of 1-10, 1 being the lowest and 10 being the highest, please rate your city's response to housing affordability and briefly explain your rating.

This is arbitrary because there are so many factors, but I'll say 6. Passage of Forward Dallas opens up density in logical areas like DART Stations for Transit Oriented Development, which can bring more units to stabilize market pricing, but also help an individual with reducing their transportation costs. I am particularly excited by the Community Land Trust that TREC is standing up to activate vacant parcels for single family homes and multi-family like townhomes to bring affordable options in categories that have become out-of-reach for most residents.

8. Please list a specific policy/ordinance you would like to introduce or repeal to address the housing supply issue

I'd like to see the impact of Forward Dallas on new development in sensible locations like TODs and along arterials and major intersections, but if there are housing proposals brought forth, as a member of the Housing & Homelessness Committee, I'll give careful consideration.

9. What's the biggest threat to LGBTQ+ folks with respect to housing security and what are your plans to address housing insecurity within this community specifically?

The opening of Oak Lawn Place is a great example of ways a city can work with a nonprofit to close funding gaps to bring a project like this to life. Supporting those who have ideas and projects like this is one thing a council member, and City, can do. Housing security is under threat to many populations right now with some recent state legislation that has been introduced.

10. What specific ordinances or policies would you suggest or support to address housing inequality and rental pricing, such as a ban on algorithmic rent control?

I have not researched algorithmic rent control but am open to learning more.

11. On a scale of 1-10, 1 being the lowest and 10 being the highest, please rate your city's delivery of public safety services to the community and briefly explain your rating.

*

Since a rating would be arbitrary, I'll say that we do need to hire more police officers, but thoughtfully in a way that does not pull too many officers from patrol to train recruits. We need to listen to law enforcement leadership on this. Dallas' violent crime rate, with just under 3100 officers, has been reduced by almost 50% in five years, which shows that use of technology and the Violent Crime Reduction Plan are working. That said, response times are much higher than average across all categories. I serve on the Public Safety Committee and review the recruitment and retention figures and initiatives each month—Dallas is moving in the right direction.

12. Please list one public safety policy you support and why and one public safety policy you oppose and why.

*

I support raising the floor to 300 from 250 for 2024-25 hiring and oppose the current status of college credits required for hiring (would like to see work experience be counted to a degree).

13. Please address how you would work with public safety officials across all appropriate levels * of government to ensure LGBTQ+ people feel safe, secure, and respected within your respective jurisdiction.

Ensuring that the law is applied equitably and that discrimination in protection or investigation do not occur is something that has to be in place. I am not hearing of anything otherwise so would like to hear from the community if that is not the case.

I am not aware of any recent cases, but if there are any, would like them brought to my attention.
